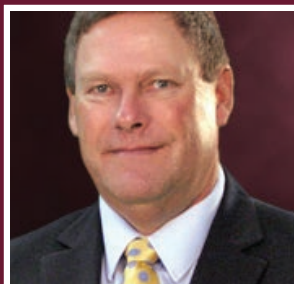


TAMARA SCOVILLE
